### Medical Marijuana (MMJ) Expertise

The California MMJ laws are a key area of focus for Mr. Chernis, who makes it his business to keep abreast of changes in the MMJ laws and arm clients with that knowledge. It is his prime directive to keep clients out of harm's way, and he believes an educated and informed client is critical to the equation.

Mr. Chernis has represented clients seeking to form legal MMJ collectives and cooperatives; storefront and mobile dispensaries; cultivators; MMJ patients and doctors; landlords and others seeking to do business in the MMJ sector; and individuals and businesses in civil litigation arising from such activities. Mr. Chernis also represents individuals and businesses in federal criminal matters and those charged with violating state MMJ laws and has successfully asserted defenses under the California MMJ laws on behalf of a number of clients – including marijuana cultivators, transporters and dispensary owners and employees. Although the California MMJ laws are not applicable in Federal court, Mr. Chernis has in a number of instances successfully used a client's compliance with those laws to persuade federal prosecutors not to file criminal charges.

Mr. Chernis is a member of many legal organizations that advocate on behalf of marijuana users and providers, including the National Association of Criminal Defense Attorneys, the Lawyers Committee for the National Organization for the Reform of Marijuana Laws (NORML), and California NORML.


